5. MY LINCOLNWOOD STORY PRESENTATION

6. REVIEW PATRON CONTENT POLICY

Trustees reviewed statistics and information related to the usage of the Lincolnwood Library by Chicago residents. The Board discussed the pros and cons of additional restrictions and agreed to continue the discussion at the February Board meeting.
